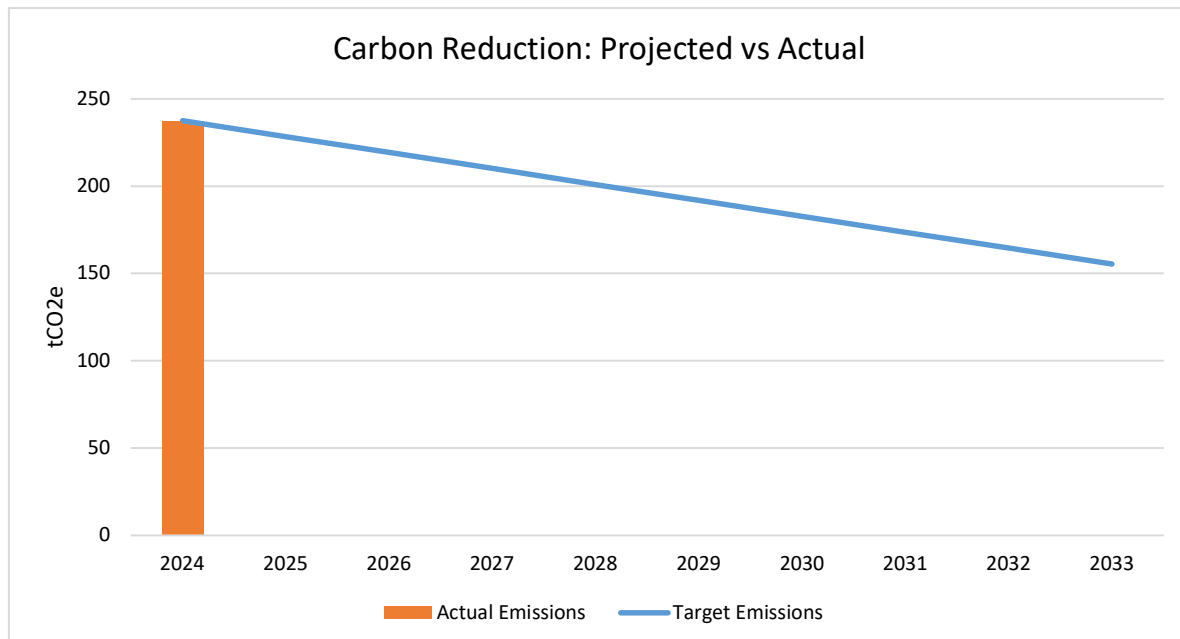

In order to continue our progress to achieving Net Zero, we have adopted the following carbon reduction targets.

We project that carbon emissions will decrease over the next five years to 191.9 tCO₂e by 2029. This is a reduction of 19.2 %

Completed Carbon Reduction Initiatives

The following environmental management measures and projects have been completed or implemented since the 2024 baseline and the measures will be in effect when performing the contract.

- We offer the Electric Vehicle Car Scheme which 6 of our employees took up last year, contributing to reduced emissions for business travel and commuting.

Future Carbon Reduction Initiatives

In the future we hope to implement further measures such as:

- We will communicate with our skip providers to notify them of our aim to reach net zero by 2050 and request their support in decarbonising our scope three emissions, as well as improved data recording on types and weight of waste that we are disposing of as a result of our operations. This will be achieved by Q4 2025 and measured against our baseline throughout the next reporting period.
- We will inform our employees of methods they can use to reduce their emissions during essential business and commuting travel in their vehicles. This will be communicated via company-wide comms on driving efficiency. This will be achieved by Q4 2025 and measured against our baseline throughout the next reporting period.
